**ART.1: ORGANIZATION**

REGIONAL OLIMPIC COMMITTEE CONI AND GORIZIA CONI DELEGATION ORGANIZES AN INTERNATIONAL TOURNAMENT ENTITLED "DELLE NAZIONI". THE TOURNAMENT WILL BE PLAYED FROM APRIL 25<sup>TH</sup> TO MAY 1<sup>ST</sup> 2015.

**ART.2: CATEGORY OF PARTICIPATION AND AGE LIMITS**

THE TOURNAMENT IS RESERVED TO THE YOUNG BELONGING SOCCER PLAYERS TO THE CATEGORY ALLIEVI REGULARLY ENROLLED WITH HIS/HER OWN SOCIETY AND FEDERATION BELONG FOR THE SEASON IN PROGRESS HAD BEEN BORN FROM 1<sup>ST</sup> JANUARY 1999 TILL 14 YEARS OLD.

**ART.4: FOOTBALL PLAYERS LIST**

A LIST OF PLAYERS ELIGIBLE TO PARTICIPATE SHALL BE PRODUCED TO THE ORGANIZER COMMITTEE BEFORE THE START OF THE TOURNAMENT. LISTS SHALL COMPRISE A MAXIMUM OF 20 PLAYERS.

ONCE THE LISTS HAVE BEEN DELIVERED TO THE ORGANIZER COMMITTEE, THIS CAN NOT BE CHANGED.

THE LIST OF PLAYERS FOR TEAM, THAT SHALL BE PRODUCED FOR THE REFEREE IS LIMITED TO 20 PLAYERS.

**ART.5: SUBSTITUTION**

SUBSTITUTION ARE ALLOWED IN NUMBER OF 7 AT ANY TIME OF THE MATCH AND INDEPENDENTLY FROM THE ROLE OF THE PLAYERS.

**ART.6: PARTICIPATING TEAMS**

**ART.7 TOURNAMENT FORMULA**

12 NATIONAL TEAMS WILL BE ADMITTED AND DIVIDED INTO 3 GROUPS OF 4 TEAMS EACH. AFTER THE GROUP STAGE THE THREE FIRST TEAMS AND THE BEST SECOND TEAM WILL QUALIFY FOR THE SEMIFINALS AND FINALS FOR 1<sup>ST</sup>, 2<sup>ND</sup>, 3<sup>RD</sup> AND 4<sup>TH</sup> PLACE; OTHER TWO SECOND TEAMS AND BEST TWO THIRD TEAMS WILL QUALIFY FOR THE SEMIFINALS AND FINALS FOR 5<sup>TH</sup>, 6<sup>TH</sup>, 7<sup>TH</sup> AND 8<sup>TH</sup> PLACE; LAST THIRD TEAM AND ALL FOURTH TEAMS WILL QUALIFY FOR THE SEMIFINALS AND FINALS FOR 9<sup>TH</sup>, 10<sup>TH</sup>, 11<sup>TH</sup> AND 12<sup>TH</sup> PLACE.

## **ART. 8 RANKING**

THE RANKING WILL BE DRAWN UP IN LIGHT OF THE FOLLOWING CRITERIA:

3 POINTS FOR WIN - 1 POINT FOR DRAW - 0 POINTS FOR DEFEAT

IN CASE OF EQUAL POINTS APPLY THE CRITERIA IN ORDER LISTED:

1. OUTCOME OF MEETINGS DIRECT
2. DIFFERENCE NETS IN DIRECT MEETING BETWEEN THE TEAMS TO EQUALITY OF POINTS
3. DIFFERENCE NETS ON TOTAL OF MEETINGS PLAYED IN ROUND
4. HIGHEST NUMBER OF GOALS SCORED ON TOTAL OF MEETINGS PLAYED IN ROUND
5. DRAWING

SEMIFINALS, WHICH WILL BE PLAYED AS KNOCKOUT COMPETITION, WILL BE PLAYED BY 3 FIRST OF EACH GROUP AND THE BEST SECOND AND THE TEAMS WILL BE ADMITTED AS FOLLOWS:

1<sup>ST</sup> TO 4<sup>TH</sup> PLACE

- A) FIRST QUALIFIED OF GROUP A AGAINST FIRST QUALIFIED OF GROUP B;
- B) FIRST QUALIFIED OF GROUP C AGAINST FIRST OF SECONDS QUALIFIED;

FIRST OF SECONDS QUALIFIED PLAYED IN GROUP C, COUPLING WILL BE:

- A) FIRST QUALIFIED OF GROUP A AGAINST FIRST OF SECONDS QUALIFIED;
- B) FIRST QUALIFIED OF GROUP B AGAINST FIRST QUALIFIED OF GROUP C;

5<sup>TH</sup> TO 8<sup>TH</sup> PLACE

- A) SECOND OF SECOND QUALIFIED AGAINST SECOND OF THIRD QUALIFIED;
- B) THIRD OF SECOND QUALIFIED AGAINST FIRST OF THIRD QUALIFIED;

IF TWO OR ALL FOUR TEAMS REPORTED IN PREVIOUS COUPLING PLAYED IN SAME GROUP, COUPLING WILL BE:

- A) SECOND OF SECOND QUALIFIED AGAINST FIRST OF THIRD QUALIFIED;
- B) THIRD OF SECOND QUALIFIED AGAINST SECOND OF THIRD QUALIFIED;

9<sup>TH</sup> TO 12<sup>TH</sup> PLACE

- A) FOURTH QUALIFIED OF GROUP A AGAINST FOURTH QUALIFIED OF GROUP B;
- B) FOURTH QUALIFIED OF GROUP C AGAINST THIRD OF THIRD QUALIFIED;

IF THIRD OF THIRD QUALIFIED PLAYED IN GROUP C, COUPLING WILL BE:

- A) FOURTH QUALIFIED OF GROUP A AGAINST THIRD OF THIRD QUALIFIED;
- B) FOURTH QUALIFIED OF GROUP B AGAINST FOURTH QUALIFIED OF GROUP C;

## **ART.9 HALVES OF GAMES**

GROUP STAGE MATCHES WILL BE PLAYED IN 2 (TWO) TIMES OF 35 MINUTES EACH.

SEMIFINALS AND FINALS MATCHES WILL BE PLAYED IN 2 (TWO) TIMES OF 40 MINUTES EACH.

MATCHES ARE PLAYED ON 11V 11 REGULAR FOOTBALL FIELD WITH REGULAR DOOR AND NUMBER BALLS FIVE.

## **ART.10 PENALTY (FORESEEN IN)**

AFTER GROUP STAGE, IN CASE OF DRAW (EXCEPT FOR 1<sup>ST</sup> – 2<sup>ND</sup> PLACE FINAL) AFTER END OF REGULAR TIME, PENALTIES WILL BE KICKED.

PENALTIES WILL BE MADE WITH THE CRITERIA FIXED BY ARTICLE 7 OF THE RULES OF THE GAME AND OF THE OFFICIALS DECISIONS.

## **ART.11. EXTRA TIME (IF FORESEEN, ONLY FOR 1<sup>ST</sup> – 2<sup>ND</sup> PLACE FINAL)**

ONLY FOR 1<sup>ST</sup> – 2<sup>ND</sup> PLACE FINAL, IN CASE OF DRAW AFTER END OF REGULAR TIME, TWO EXTRA TIMES OF TEN MINUTES EACH WILL BE PLAYED. IN CASE OF DRAW ALSO AFTER END OF EXTRA TIMES, PENALTIES WILL BE KICKED AS PER ARTICLE 10.

#### **ART.12 REFEREES**

THE MATCHES WILL BE DIRECTED BY REFEREES F.I.G.C. / A.I.A.

#### **ART. 13 TOURNAMENT COMMITTEE**

THE TOURNAMENT COMMITTEE WILL BE IN CHARGE OF EVERY QUARELL, PROTEST, COMPLAINT AND ANY OTHER UNFORESEEN CIRCUMSTANCE. MEMBERS OF THE COMMITTEE ARE:

WHEN NECESSARY THE COMMITTEE WILL SEND A REPORT TO THE NATIONAL FEDARATION.

THE COMMITTEE WILL NOT ACCEPT ANY PROTEST OR COMPLAINT ABOUT REFEREE DECISIONS.

MISCONDUCT OF PLAYERS WILL BE SIGNALLED TO THEY OWN FEDERATIO, WHICH WILL TAKE THE MORE APPROPRIATE FINAL DECISON.

MISCONDUCT OF ANY OF THE MEMBERS OF THE PARTEICIPANTING DELEGATIONS WILL BE REPORTED IN WRITTEN BY THE TOURNAMENT COMMITTEE TO THE NATIONAL AND INTERNATIONAL FEDERATION, WHICH WILL TAKE THE MORE APPROPRIATE FINAL DECISON.

#### **ART.14 DISCIPLINE OF THE TOURNAMENT**

THE TOURNAMENT REGULATION WILL BE GRANTED BY THE REGULAR/SUPPLY ARBITRATOR OF THE GORIZIA REGIONAL COMMITTEE.

#### **ART.15 IMMEDIACY OF SANCTIONS (FOR THE TOURNAMENT OF RAPID DEVELOPMENT)**

THE IMMEDIACY OF SANCTIONS IS PROVIDED BY REGULATIONS AS FOLLOWS: A PLAYER SENT OFF DURING A GAME WILL NOT PARTECIPATE TO THE FOLLOWING MATCH, EXCEPT IN CASE OF MORE SEVERE SANCTIONS IMPOSED BY THE SPORT JUDGE; A PLAYER CAUTIONED TWICE DURING THE TOURNAMENT WILL BE DISQUALIFIED FOR A MATCH AFTER A SANCTION OF THE SPORT JUDGE.

#### **ART.16 COMPLAINT**

ALL PROTESTS OR COMPLAINTS SHALL BE MADE TO THE TOURNAMENT COMMITTEE, WHOSE DECISION SHALL BE FINAL AND BINDING.

THE COMPLAINT HAVE TO BE PUT FORWARD BY 30 MINUTES FROM THE END OF THE MATCH AFTER HAVING PAID A TAX OF **€ 52, 00**. A COPY OF THE CLAIM HAS TO BE PUT FORWARD TO THE COUNTERPART BY 30 MINUTES FROM THE END OF THE MATCH. **THE COMMITTEE WILL NOT ACCEPT PROTESTS OR COMPLAINTS RELATING TO DECISIONS TAKEN BY THE REFEREE.**

#### **ART. 17 INSURANCE**

EVERY PARTICIPANT CLUB HAS TO PROVIDE HIS PLAYERS THE INSURANCE COVER.

THE TOURNAMENT ORGANIZATION IS RESPONSIBLE OF THE REGULARITY OF THE INSURANCE COVER.

#### **ART.18 I.F.A.B.**

THE MATCHES ARE PLAYED WITH THE RULES OF THE INTERNATIONAL FOOTBALL ASSOCIATIONS BOARD (IFAB) OF THE CURRENT EDITION.

#### **ART. 19 "EDUCATIONAL MEETING"**

DURING THE TOURNAMENT THE ORGANIZING CLUB WILL ORGANIZE, IN COLLABORATION WITH THE YOUTH AND SCHOOL DEPARTMENT, A TECHNICAL AND EDUCATIONAL MEETING DIRECTED TO TECHNICIANS, MANAGERS, PARENTS AND FOOTBALL PLAYERS.

#### **ART.20 GENERAL RULES**

AS REGARDS ANYTHING NOT EXPRESSLY PROVIDED BY THIS REGULATIONS, ARE VALID NORMS OF REGULATIONS FEDERAL AND REGULATIONS REPORTED ON THE OFFICIAL STATAMENT N.1 FOR YOUTH AND SCHOOL SECTOR CONCERNING THE SEASON CURRENT.

**A) GREETING**

THE DIRECTORS AND OPERATORS OF THE PARTICIPANT GROUPS WILL HAVE TO MAKE SURE THAT AT THE BEGINNING AND AT THE END OF EACH GAME, THE PARTICIPANTS AND THE PUBLIC WILL GREAT EACH OTHER BY SHACKING HANDS.

**B) WAITING TIME**

THE TEAMS WILL HAVE TO BE ON THE PITCH WITH THE UNIFORM WITHIN 15 MINUTES ON THE FIXED TIME.

**C) INTERRUPTION OF GAME**

DURING THE PRELIMINARY PHASE, IN CASE OF INTERRUPTION OF THE MATCH DUE TO IMPRACTICABILITY OF THE PITCH, THE RESULT SINCE THEN WILL BE VALID, WHILE IN THE FINAL PHASE IF THE SCORE IS TIED BETWEEN THE TWO TEAMS, A DRAW IS DECLARED BETWEEN THE REFEREE AND THE CAPTAINS OF THE TEAMS.

**D) FAILING OF A GAME'S START**

IF THE GAME DOESN'T START DUE TO A QUESTION OF FORCE MAJEURE, AND IT'S NOT DEPENDING BY THE TEAMS, A DRAW IS DECLARED AND TO THE WINNER WILL BE ASSIGNED A SCORE OF 3-0.
