LIST OF PERMITTED AND PROHIBITED ITEMS

(demonstrative listing)

Spectators must not bring items that can be thrown onto the players' field or into the stadium seating areas, or that can be used to disturb or jeopardize the quietness, order and security in the stadium. This particularly applies to the following items:

PERMITTED

- a) Telescopic umbrellas;
- b) Functional mobile phones;
- c) Functional photo cameras (incl. batteries or rechargeable batteries);
- d) Walking aids, white cane (for blind or visually impaired people);
- e) iPods, Walkman or Discman (incl. batteries or rechargeable batteries);
- f) Keys;
- g) Medication (incl. injections and glass containers) with proof of medical necessity;
- h) Flag poles up to a length of 130 cm or a maximum diameter of 2 cm;
- i) Flags and banners of the material category "fire resisting" and that comply with the regulations in points 1. i and 1. m;
- j) Wallets (incl. wallet chains);
- k) Commercial pocket lighters, binoculars;
- l) Service dogs (e.g. for blind or visually impaired people)

PROHIBITED

- a) Weapons of any kind;
- b) Items that can be used as weapons or projectiles, in particular rocks, items made of metal, individual batteries, non-functioning mobile phones, bottle openers, removable chains, iron rods, and iron pieces;
- c) Walking-stick umbrella with wooden or metal tips;
- d) Helmets of any kind;
- e) Bottles, cups, mugs and jars of any kind, as well as other items made of materials like PET, glass or other breakable, shattering or particularly solid materials;
- f) Other beverage containers of any kind, particularly thermos bottles;
- g) Pyrotechnical articles of any kind, particularly fireworks, flares, smoke powder, smoke bombs, firecrackers;

- h) Alcoholic beverages of any kind, drugs and stimulants;
- i) Racist, anti-immigrant, right-wing extremist, National Socialist, sexist or political propaganda material;
- j) Flags and banners longer than 130 cm or a diameter of more than 2 cm;
- k) Flags and banners that are not under the material category “ fire resisting” ;
- l) Pets, except service dogs;
- m) Any advertisement, commercial, political, or religious objects including banners, flags, signs, symbols, flyers, and similar objects; as well as advertisement and commercial objects of any kind;
- n) Aerosol cans, acidly, flammable, and coloring substances or containers holding such substances that can affect the health of people, or that are flammable. In particular, perfume and nail polish;
- o) Bulky objects such as ladders, stools, (folding) chairs, boxes, strollers, bicycles, skateboards;
- p) Bulky, large bags, large backpacks, suitcases, sport bags. Bulky bags/luggage within the scope of this ordinance refers to all pieces of luggage that are larger than 25 cm x 25 cm x 25 cm and that cannot be placed underneath the respective seat in the stadium;
- q) Mechanically operated noise instruments such as megaphones, air-horns, and horns of any type (e.g. Vuvuzela);
- r) Larger amounts of paper or paper rolls;
- s) Laser-pointers of any type;
- t) Bottle openers;
- u) Large key chains and key holders;
- v) Darts;
- w) Ski masks, balaclavas and similar head covers.
